If rental fee is not paid by August 16, 2010 then Renter grants Galloway Productions the right to cancel the tent order. Because the event will go on rain or shine, all tent charges are non-refundable. Renter agrees to assume the risk of and hold Galloway Productions harmless for property damage and personal injuries caused by the rental items and/or arising out of Renter's negligence. Renter agrees not to use or allow anyone to use the rental items for any illegal purpose or in any illegal manner. Renter agrees not to cook under tent or anywhere on Turner Field property. Renter also agrees not to use tape on tent. Galloway Productions shall not be liable for injuries or damages caused by fire from any cause, rain, hail, sleet, snow, storm, high winds, tornado, floods or other disturbances by nature or by tents falling by reason thereof upon any persons, materials, or exhibits while under, near or about the rental items. Galloway Productions shall not be liable in any manner for injuries or damages caused to persons or things falling over or coming in contact with ropes, chains, stakes or other supports of the rental items. It is understood that the rental items are not guaranteed to be waterproof although processed with special water-resistant compounds. Renter agrees to hold Galloway Productions harmless from any demand or claim whatsoever for bodily injury or property damage arising from the use of rental items or materials furnished hereunder.
